



The MVS B (Meredith Village Savings Bank) “Vote for your favorite nonprofit serving Exeter” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The MVS B (“MVS B”) “Vote for your favorite nonprofit serving Exeter” sweepstakes is sponsored by MVS B (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The MVS B “Vote for your favorite nonprofit serving Exeter” sweepstakes begins at approximately 8:00 am Eastern Time (“ET”) on Wednesday, July 1, 2024 and ends at approximately 11:59:59pm ET on Wednesday, July 31, 2025 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

AGREEMENT TO OFFICIAL RULES: By participating in the MVS B “Vote for your favorite nonprofit serving Exeter” sweepstakes, each entrant agrees to be bound by these Official Rules, including all eligibility requirements, and unconditionally accepts the decisions of the Sponsor, which are final and binding. Limited to one (1) in person and one (1) online vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.
