



The MVS B (Meredith Village Savings Bank) “Vote for your favorite nonprofit serving Exeter” Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER, WIN, OR VOTE. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The MVS B (“MVS B”) “Vote for your favorite nonprofit serving Exeter” sweepstakes is sponsored by MVS B (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The MVS B “Vote for your favorite nonprofit serving Exeter” sweepstakes begins at approximately 8:00 am Eastern Time (“ET”) on Wednesday, July 1, 2024 and ends at approximately 11:59:59pm ET on Wednesday, July 31, 2024 (the “Sweepstakes or Voting Period”). Votes/entries received after that date will be deemed ineligible to win.

Limited to one (1) in person and one (1) online vote per person. Mechanically reproduced or potentially fraudulent votes/entries, as determined by Sponsor in its sole discretion, will be discarded.
