

The MVSB (Meredith Village Savings Bank) "Vote for your favorite nonprofit serving Exeter" Sweepstakes Official Rules

SPONSOR: The MVSB ("MVSB") "Vote for your favorite nonprofit serving Exeter" sweepstakes is sponsored by MVSB (Sponsor), PO Box 177, Meredith, NH 03253-0177.

SWEEPSTAKES PERIOD: The MVSB "Vote for your favorite nonprofit serving Exeter" sweepstakes begins at approximately 8:00 am Eastern Time ("ET") on Wednesday, July 1, 2024 and ends at approximately 11:59:59pm ET on Wednesday, July 31, 2024 (the "Sweepstakes or Voting Period"). Votes/entries received after that date will be deemed ineligible to win.
